GWW in a kisam pelmawh panpih piaknate in innkuan sung ngongtatna a thuak kha mimalte panpihna ah a neih theih uh a tuam vilvel vaipuak theitel in, innkuan ngongtatna hangin a thuak ka mite uh panpih ding hanciam hi. Tua pen mipi leh Gam nakpitakin khangtosak ding cih ka ngimna uh tawh kituak hi. Ka mite uh pen nasem, naseppih, customer-te leh tualsung mipi kipawlkhawmte ahi uh hi.
